Other Information

- Applications for the following will be considered received only after review by the Racine County Development Services office is complete: Site Plans, Conditional Uses, Rezoning, Variances and Land Use Plan Amendments. Land Use Plan Amendments must be received a minimum of 30 days in advance of the meeting where they will be considered due to publication requirements.
- Applications for the following will be considered received only after review by the Town engineer's office is complete: Certified Survey Maps and Subdivision Plats.

Application Fees:

- Conditional Uses, Rezoning and Variances - \$75 each plus \$6.47 (or current certified mail rate) for each property owner (other than applicant) within 300 feet of subject property
- Certified Survey Maps - \$100 for each parcel created (including parent parcel) plus \$6.74 (or current certified mail rate) for each property owner (other than applicant) within 300 feet of subject property
- Site Plans - \$30
- Kennel Licenses - \$100
- Occupancies, Holding Tank Agreements, Shoreland Agreements - \$0
