**TOWN OF YORKVILLE
RACINE COUNTY, WISCONSIN**

**A RESOLUTION AUTHORIZING THE PURCHASE OF A TANKER TRUCK AND
RADIO EQUIPMENT FOR THE UNION GROVE-YORKVILLE FIRE DEPARTMENT**

**THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY,
WISCONSIN, RESOLVES AS FOLLOWS:**

WHEREAS, the Town of Yorkville and the Village of Union Grove entered into an agreement dated July 31, 1973, and amended March 8, 1995, for the continuation and improvement of fire and rescue services to the areas served for both municipalities by the Union Grove-Yorkville Fire Department and such agreement established rules and procedures governing fire and rescue equipment, motor vehicles, and real property, and the purchase thereof (the "Agreement"); and

WHEREAS, from time-to-time the Town or Village will agree to borrow funds to pay for fire and rescue equipment, motor vehicles, and real property for the Union Grove-Yorkville Fire Department and the Town and Village will share proportionally in the repayment of the debt in accordance with the Agreement; and

WHEREAS, when the Town or Village borrows funds, the loan payments are made directly by the Union Grove-Yorkville Fire Department and the Union Grove-Yorkville Fire Department budgets for such payment and such budget is supported proportionately by the Town and Village in accordance with the Agreement; and

WHEREAS, the Union Grove-Yorkville Fire Department has asked the Town to borrow \$216,863.70 to pay for the purchase of a tanker truck and radio equipment and the Town is prepared to adopt a Resolution 2015-08 authorizing the submission of an application to the Board of Commissioners of Public Lands of Wisconsin to request a General Obligation Loan in an amount not to exceed \$216,863.70 for these purposes; and

WHEREAS, the Town is prepared to incur this debt based on the repayment of the debt occurring in accordance with the Agreement and the Village being responsible for its share in accordance with the Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Yorkville, Racine County, Wisconsin, that the Town Board will adopt Resolution 2015-08 Authorizing the submission of an application to the Board of Commissioners of Public Lands of Wisconsin to request a General Obligation Loan in an amount not to exceed \$216,863.70 for the purposes of purchasing a tanker truck and radio equipment on behalf of the Union Grove-Yorkville Fire Department conditioned on the Village adopting a resolution acknowledging the loan and the repayment of this loan in accordance with Agreement; and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes Section 60.80(1); and

BE IT FURTHER RESOLVED, that this resolution takes effect the day following its posting.

This Resolution was adopted by the Yorkville Town Board on June 22, 2015.
