TOWN OF YORKVILLE RACINE COUNTY, WISCONSIN

A RESOLUTION TO UPDATE THE FEE SCHEDULE FOR FEES ESTABLISHED BY YORKVILLE TOWN BOARD POLICY AND VARIOUS PROVISIONS OF THE TOWN OF YORKVILLE CODE OF ORDINANCES

THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:

WHEREAS, the Yorkville Town Board enacted Resolution 2008-01 on December 22, 2008, which is an abbreviated and uniform schedule of fees established and charged by the Town of Yorkville per Yorkville Town Board policy and various provisions of the Town of Yorkville Code of Ordinances; and

WHEREAS, the Yorkville Town Board may update this fee schedule by adoption of a resolution, from time to time and as the need arises, if the fees enumerated within are not sufficient to defray the costs for which those fees are collected and intended to cover or if changes to the Town of Yorkville Code of Ordinances require that said changes be made.

NOW, THEREFORE, BE IT RESOLVED, by the Yorkville Town Board that the fees for certain services are either not sufficient to defray the costs for which those fees are collected and intended to cover or must be changed to reflect updates made to the Town of Yorkville Code of Ordinances, and

BE IT FURTHER RESOLVED, by the Yorkville Town Board that the Town of Yorkville fee schedule be amended with the following updates to those fees for certain services:
