

RESOLUTION NO. 02-2013

TOWN OF YORKVILLE
RACINE COUNTY, WISCONSIN

A RESOLUTION ADOPTING THE 2013 PROPERTY TAX LEVY FOR THE TOWN OF YORKVILLE

RECITALS:

WHEREAS, the Yorkville Town Board and all subunit committees of the Town of Yorkville, through the budgeting process, are responsible for appropriating the funds necessary for the efficient and responsible operation of the government, administration and operation of the Town of Yorkville and all its subunits for 2014, and

WHEREAS, the Yorkville Town Board recommended, on October 17, 2013, that \$1,012,781.00 in property tax revenue be collected to help achieve these goals, and

WHEREAS, the Yorkville Water Commission recommended, on October 15, 2013, pursuant to Wisconsin Statutes 196.03(3)(b) and in proportion to the 2013 assessed valuations in the Yorkville Water Utility District No. 1, that \$92,575.00 in property tax revenue be collected to help achieve these goals, and

WHEREAS, the Yorkville Town Board held a public hearing on the proposed 2014 Town budget on November 18, 2013, and

WHEREAS, Wisconsin Statutes 60.10(1)(a) authorizes town electors to adopt a tax levy at a special town elector meeting, and

WHEREAS, a Special Town Elector Meeting has been called and noticed, pursuant to Wisconsin Statutes 60.12, on November 18, 2013 by the Town of Yorkville for this purpose.

NOW, THEREFORE, by majority vote of eligible Electors duly assembled and voting on November 18, 2013 at the Special Town Elector Meeting of the Town of Yorkville, Racine County, Wisconsin,

BE IT RESOLVED that said Electors hereby adopt a 2013 Town tax levy to be collected in 2014 in the amount of \$1,105,356.00, and

BE IT FURTHER RESOLVED that the Clerk-Treasurer is hereby directed to distribute said taxes upon the current tax roll of the Town of Yorkville, and

BE IT FURTHER RESOLVED that this resolution take effect upon adoption, and

BE IT FURTHER RESOLVED that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption as required by Wisconsin Statutes 60.80(1).

This Resolution was adopted by Electors of the Town of Yorkville at a Special Town Elector Meeting on November 18, 2013.


