**A RESOLUTION AMENDING THE TOWN OF YORKVILLE'S 2016  
GENERAL FUND AND WATER UTILITY FUND ANNUAL BUDGETS**

**THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN,  
RESOLVES AS FOLLOWS:**

**WHEREAS**, the Town of Yorkville's 2016 Water Utility Fund annual budget was approved by the Town of Yorkville Water Utility District Commission on October 13, 2015, and

**WHEREAS**, the Town of Yorkville's 2016 Water Utility Fund annual budget was approved by the Yorkville Town Board on November 16, 2015, and

**WHEREAS**, the Town of Yorkville's 2016 General Fund annual budget was approved by the Yorkville Town Board on November 16, 2015, and

**WHEREAS**, these budgets have individual line items where expenditures currently exceed the line item expenditures previously approved by the Town of Yorkville Water Utility District Commission and the Yorkville Town Board, and

**WHEREAS**, Wisconsin Statutes Section 66.0607(7) requires that each line item within an annual municipal budget contain sufficient funds for the payment of approved claims or orders, and

**WHEREAS**, Wisconsin Statutes Section 65.90(5)(a) provides for the amendment of individual line items within annual municipal budgets upon authorization by a vote of two-thirds of the membership of the municipal governing body, and

**WHEREAS**, the Town of Yorkville Water Utility District Commission recommended, at their meeting on February 28, 2017, that the 2016 Water Utility Fund annual budget be amended with the transfer included within and attached hereto as Exhibit "A".

**NOW, THEREFORE, BE IT RESOLVED**, that the Yorkville Town Board hereby amends the 2016 Town of Yorkville Water Utility Fund annual budget with the transfer attached hereto as Exhibit "A", based upon the recommendation made above by the Town of Yorkville Water Utility District Commission at their meeting on February 28, 2017, and

**BE IT FURTHER RESOLVED**, that the Yorkville Town Board amends the 2016 Town of Yorkville General Fund annual budget with the transfers attached hereto as Exhibit "B", and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to make the budgetary amendments described above, and

**BE IT FURTHER RESOLVED**, that the Clerk-Treasurer is hereby directed to publish a summary of this resolution, as required by Town of Yorkville Code of Ordinances Section 46-126, and

**BE IT FURTHER RESOLVED**, that this resolution takes effect upon its publication.

This resolution was adopted by the Yorkville Town Board on March 13, 2017.
