Call to Order

Town Board Chair Peter Hansen called the meeting to order at 7:00 p.m.

Roll Call

The following Town Board members were present: Peter Hansen (4728 57th Drive), Sherry Gruhn (17201 Old Yorkville Road) and Terrence McMahon (18114 52nd Road). Also present were James Moyer (216 North Colony Avenue), Roger Nuernberg (18401 65th Court) and Clerk-Treasurer Michael McKinney.

Public Hearing – The Town Board held a public hearing to present and hear public comment on the proposed 2018 budgets for the following funds: General, Sewer Utility, Stormwater Utility and Water Utility

Hansen opened the public hearing at 7:01 p.m.

Elector discussion focused on proposed 2018 General Fund budget revenues and expenditures.

Nuernberg thanked the Town Board for their scheduled repaving of 65th Court in 2018. He asked whether the Town would consider selling him the small 33-foot wide right-of-way strip adjacent to his property at the end of 65th Court. He also asked whether the Town permits houses to use shared driveways.

With no other comments forthcoming, Hansen closed the public hearing at 7:26 p.m.

Hansen called the Special Town Elector Meeting to order at 7:26 p.m.

New and Unfinished Business – Discussion and possible action on all of the following:

Resolution No. 2017-12 Adopting the Town of Yorkville's 2017 Payable 2018 Property Tax Levy

Motion (Moyer, Nuernberg) to adopt Resolution No. 2017-12 as presented, authorizing a total 2017 Payable 2018 Town property tax levy of \$1,174,009.00, distributed between a 2017 Payable 2018 General Fund property tax levy of \$1,082,059.00 and a 2017 Payable 2018 Water Utility District Fund property tax levy of \$91,950.00, Motion Carried.

Any other business to be brought before the Special Town Elector Meeting as permitted by Wisconsin Statutes Section 60.10

Nuernberg stated that he supports the proposed incorporation of the Town as a village.

No formal action was taken by the Electors on this agenda item.
